At BIHR, we help people, communities, services and policymakers to understand and use the HRA to solve and prevent real problems that impact lives.

➔ **We make existing laws work.**

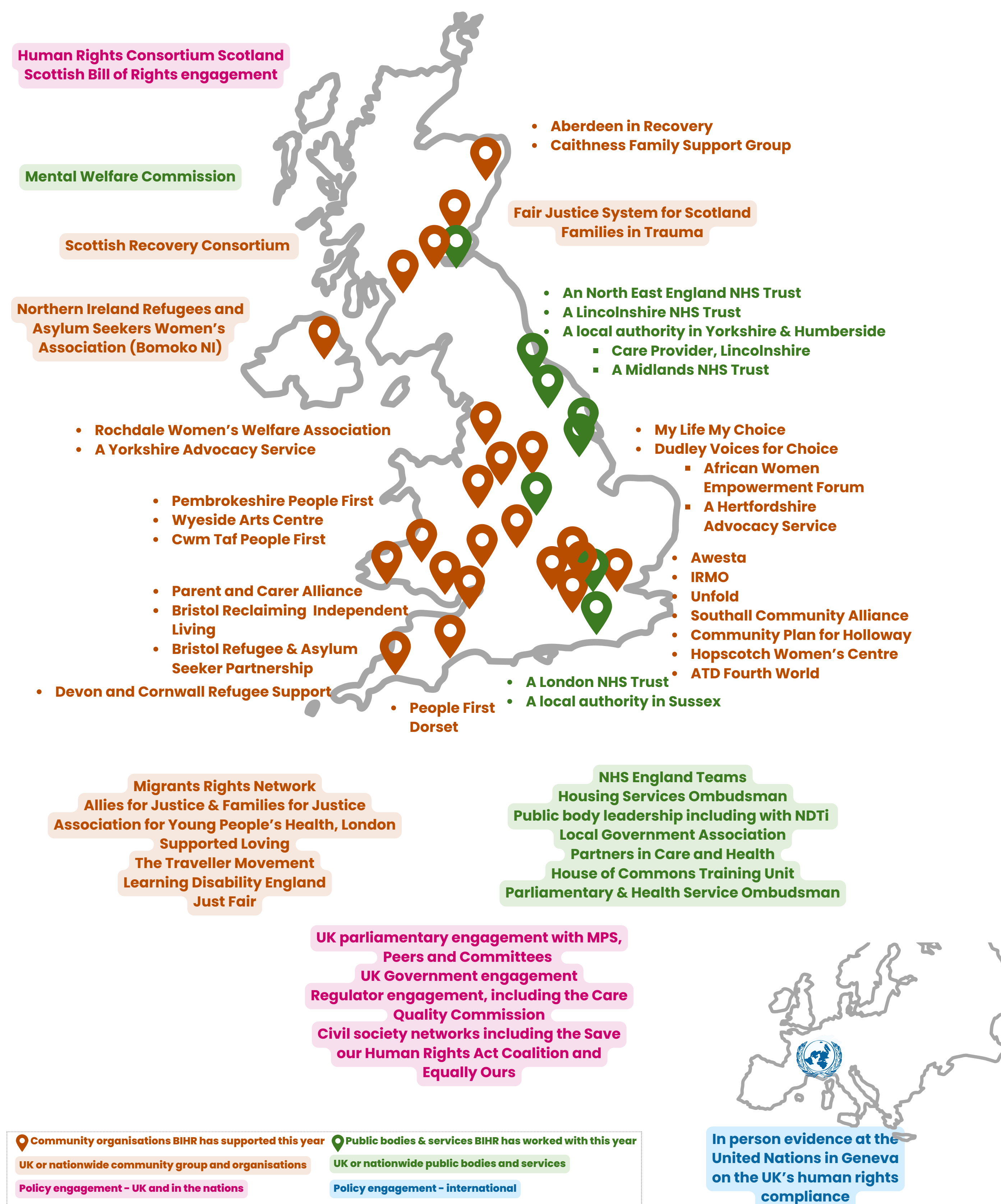
Our work supports and enables everyone: individuals, community groups, public bodies and services, governments, and parliaments.

Human rights are most powerful when people know how to use them. This year we:



Created **Easy Read** explainers and **multilingual** guides.



Provided **free workshops** for individuals and small groups.



Enabled people to **challenge poor decisions affecting care, housing decisions, and access to education.**



Empowered people become advocates in their own communities.



Supported people and civil society to understand the Human Rights Act and European Convention on Human Rights in real, relevant ways for their lives and work

5. Empowering Communities

We worked with grassroots groups, community and voluntary sector groups – small and large – to address real-life injustices using human rights advocacy. From housing to healthcare, welfare to education, we helped communities use the Human Rights Act to hold power to account.

Our UK-wide programme supported 19 community and grassroots groups across the UK to understand and use human rights in tackling injustice. Co-Produced Projects:

Advancing disabled people's rights with Cwm Taf People First

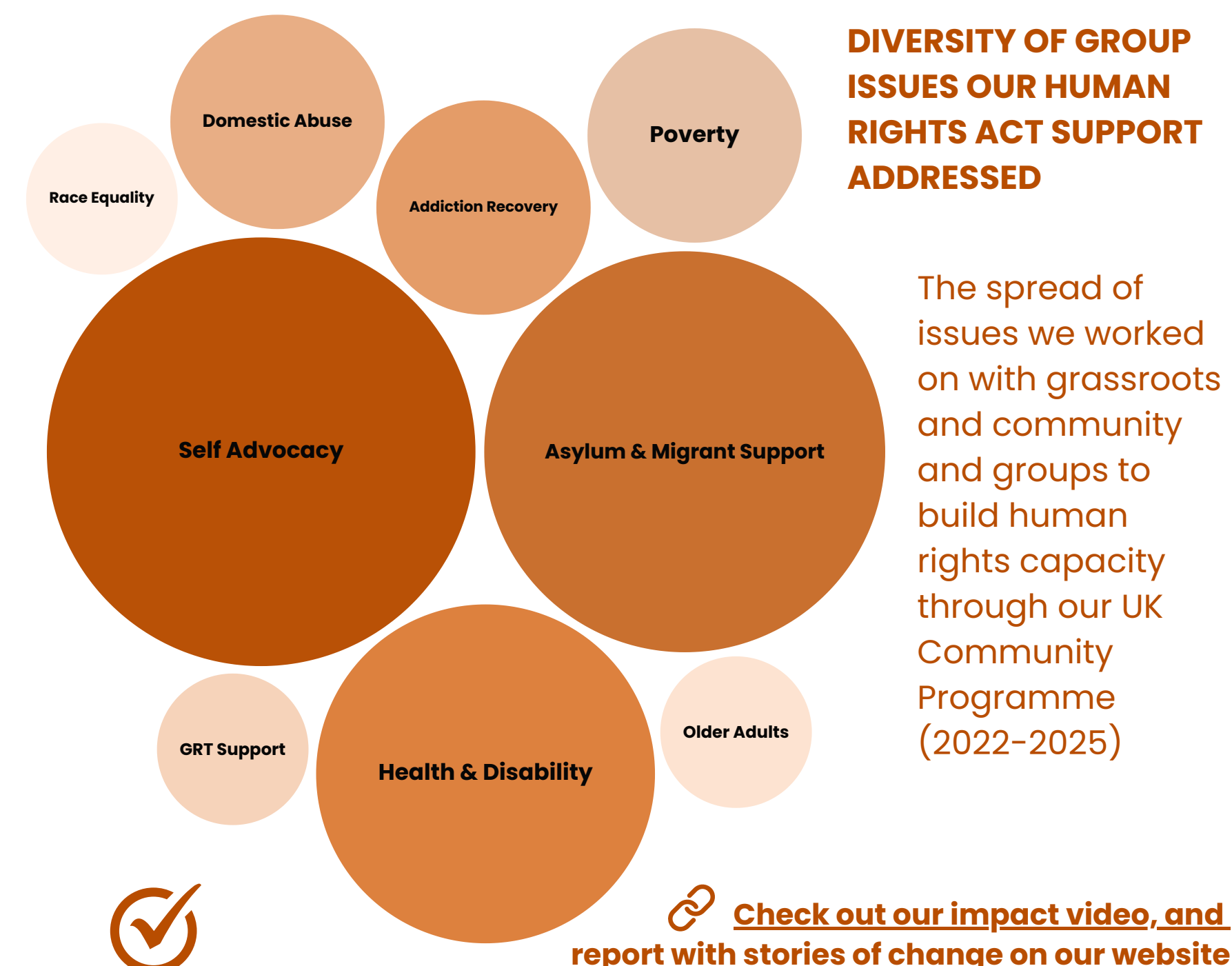
through an Easy Read card game **strengthening self-advocacy** and **working towards systemic changes** in community support (South Wales)

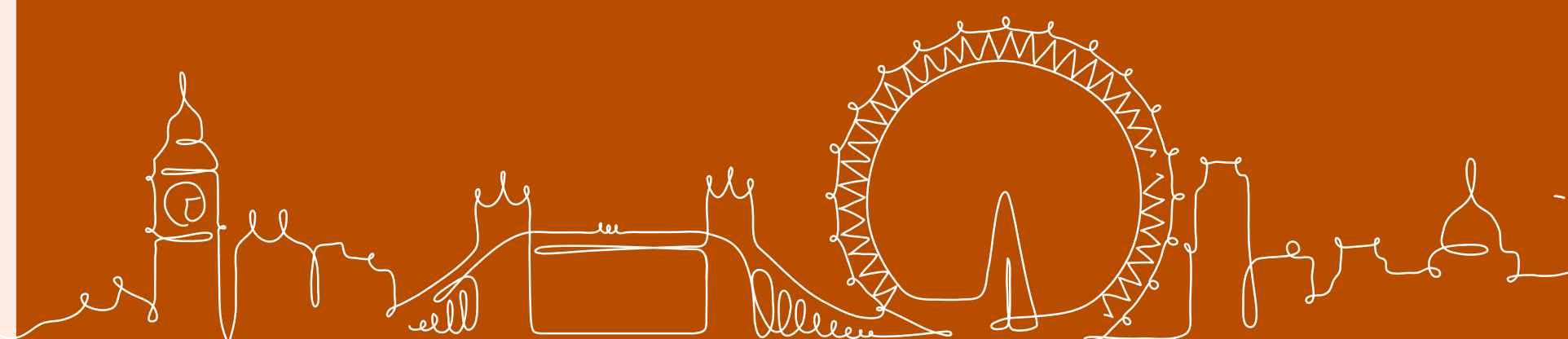

6. Building Human Rights-Respecting Public Bodies & Services

Services and bodies we worked with on human rights practice included:

Throughout 2024, BIHR enabled public sector staff to embed human rights in daily decision-making:

- ✓ Trained 800+ staff across social work, care, housing, and health.
- ✓ Co-produced a digital resource for professionals working with young autistic people and young people with learning disabilities. [Get the Guide](#) ([↗](#))
- ✓ Provided Practice Leads programmes for healthcare staff to champion human rights-based care.
- ✓ Facilitated peer learning spaces to enable human rights reflection and problem-solving with staff in public services.

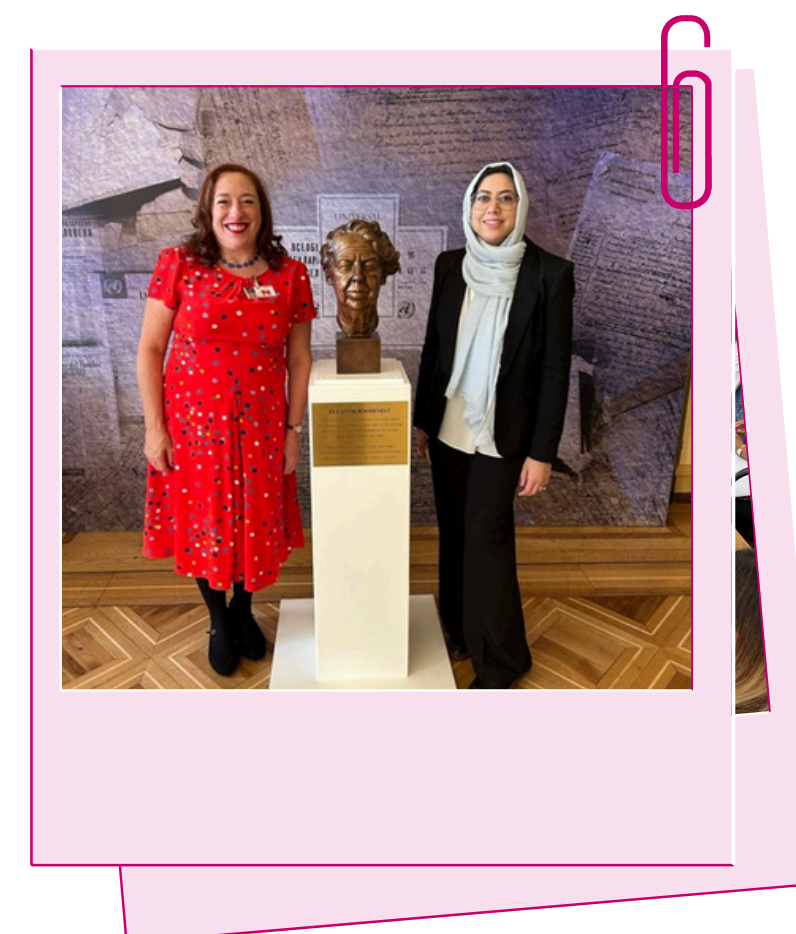

Our policy work is powered by a simple but vital principle: the Human Rights Act must be protected, understood, and used – because it works. By grounding policy analysis in the law and people’s lived experience of rights, we work to ensure **Human Rights Act is not only defended but is an enabler for EVERYONE.**

Securing the HRA

Ensuring people's lived experience of the Human Rights Act was heard at the UN [\(🔗\)](#) review of the UK's compliance with international human rights obligations (ICCPR), resulting in **recommendations** we and civil society **can harness to support HRA implementation.**

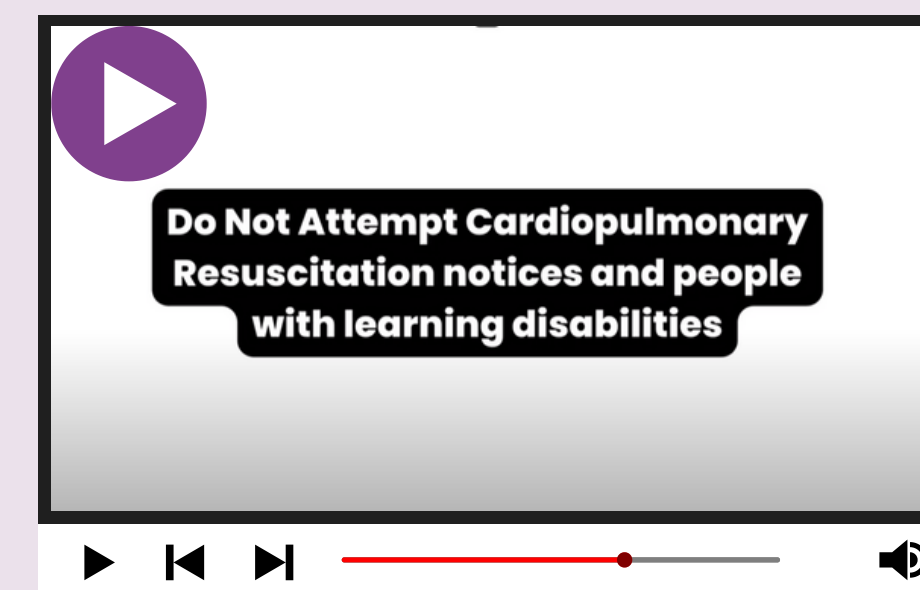

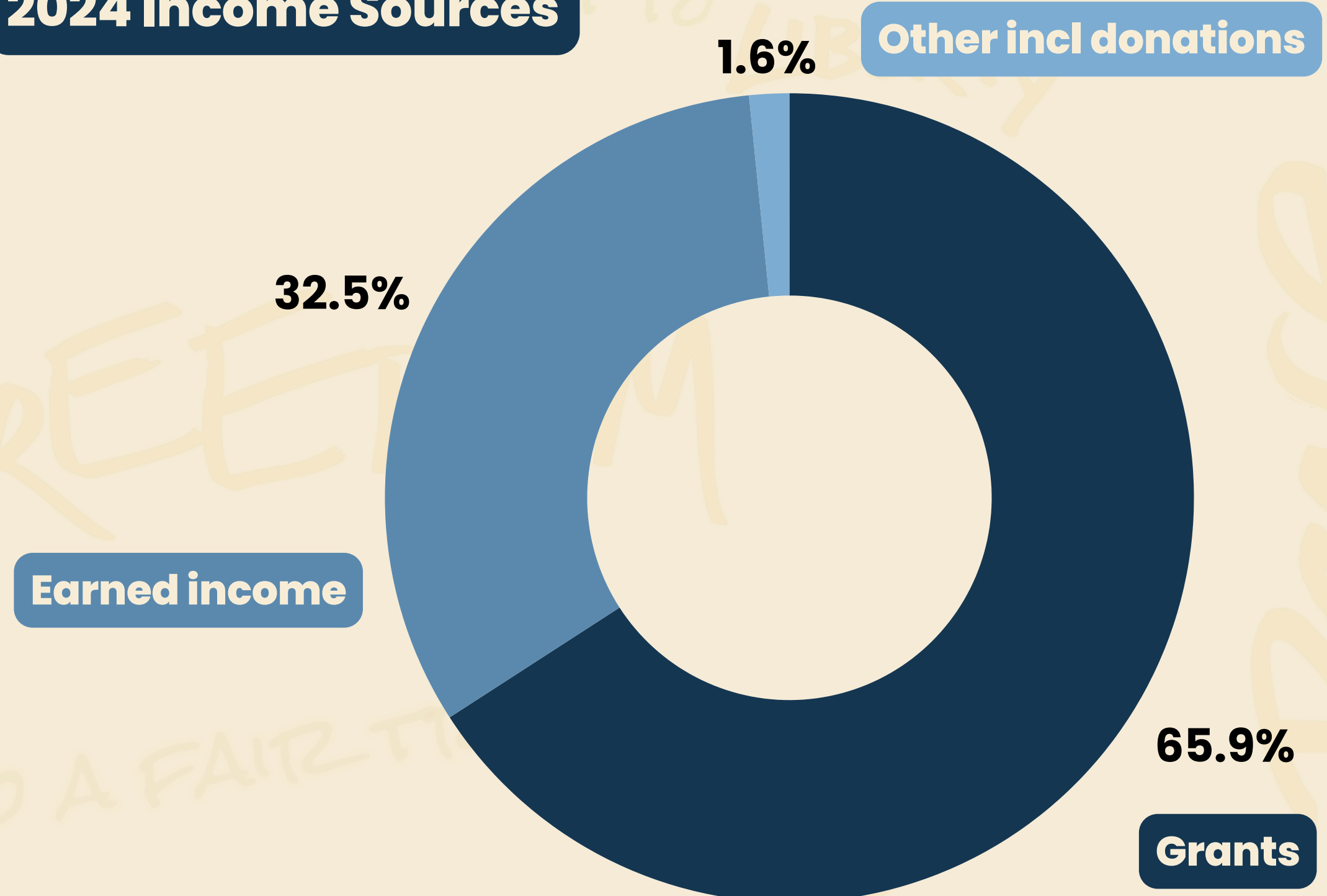
